1. Opening Remarks

The Chairperson welcomed everyone present and stated that this was a Pre-Proposal meeting for the tender for the "Consultancy Services for a Technical Investigation on the Premature Pavement Failures and Drainage Infrastructure Evaluations of the Lot 1 Portion of the Great East Road (T004) in Eastern Province of Zambia". The meeting was informed that attendance was not mandatory and it is expected that other bidders that were not in attendance would also submit proposals.
